Re: Aurora City Council's Proposal to Privatize the Public Defender

Dear Mayor Coffman and Councilmembers,

The National Association for Public Defense (NAPD) urges you to continue to provide high-quality public defense through the Aurora Public Defender's Office.

The office has proven its effectiveness: high rates of case dismissals and acquittals, and systemic advocacy to improve the fairness and accuracy of the justice system for everyone. In other words, it is serving the role set out for it in the United States and Colorado Constitutions to protect the rights of people accused of crimes.

The Council is now considering if Aurora can outsource public defense to contractors to receive the same quality of services for a considerably lower cost. It cannot. This approach will dismantle the quality and independence of public defense and make criminal trials less fair.

Contracts may work for smaller cities. But in places with higher case volumes, like Aurora, contracts incentivize attorneys to low-bid their services and cut corners on their constitutional duties to investigate and prepare each case. Contracts also make defense attorneys answerable to the executive branch, which deprives them of the independence they need to advocate for necessary resources and policy changes.

Independence is an "indispensable element" of quality representation, according to the U.S. Supreme Court and national standards.² Colorado law

thus requires each municipality to "provide independent indigent defense for each indigent defendant." Aurora has a public defense oversight commission that "shall ensure that indigent clients are represented independently." ⁴

Closing a public defender office that has been an outspoken critic of illegal law enforcement practices looks like the type of retaliation that independent systems are meant to protect against. Aurora should be proud of the quality of justice it provides and not seek to silence or shortchange it.
